## **NOTES FROM JANUARY 2018 MEETING**

## CALDERDALE HEALTH FORUM

The notes of the Health Forum held on 13 March 2017 had been received and circulated with the agenda. The Forum was attended by 3 representatives from the Group.

The Did Not Attend (DNA) table was reviewed and Heather queried where the data had come from so she would raise this with the Clinical Commissioning Group (CCG). Attendees also queried the role of Practice Champions and wondered whether this could be brought into the Practice. It was thought that this was a historical scheme that may have been continued by some practice. Heather would look into this.

## **PPG PLAN FOR FLU CLINICS**

Members agreed that a simple question of "What would you improve?" could be asked at the flu clinics. Additional demographic information would also be helpful. This would be explored further at the May meeting of the Group.

Member requested name badges so that they were identifiable when approaching patients. Heather agreed with this and confirmed that there would have to be guidelines in place for when the badges could be worn.
